Course description

Preservation is how libraries and archives sustain access to information resources, all of which are by nature impermanent. This course is an introduction to the guiding concepts and tools of the trade for preservation. In addition to learning about the characteristics of resources and the current range of technologies and methods in the field, students will examine how diverse user needs and institutional contexts shape preservation decision-making and practice.

Course Goals and Key Learning Objectives

By the end of the semester, students will be able to...

- Understand and articulate basic concepts of preserving library and archive collections
- Understand and articulate the importance of preservation in libraries, archives, and other cultural heritage institutions
- Identify formats of collections materials commonly held in libraries and archives
- Determine why and how collections deteriorate and identify ways to how to prevent further deterioration
- Identify appropriate methods for preservation decision making, including how user needs and institutional contexts shape preservation decision-making
- Advocate for preserving collections in whatever library, archive, or other institution they work in now or in the future
